





Fig.1 Output Characteristics




Fig.2 Transfer Characteristics




Fig.3 On-Resistance vs. Drain Current




Fig.4 On-Resistance vs. Junction temperature




Fig.5 Capacitance vs. Drain-Source Voltage.




Fig.6 Source-Drain Diode Forward Voltage




Fig.7 Gate-Charge Characteristics




Fig.8 Breakdown Voltage Variation vs. Temperature




Fig.9 Threshold Voltage Variation with Temperature




Fig.10 Maximum Safe Operating Area




Fig.11 PJD Normalized Transient Thermal Impedance vs. Pulse Width


