### Potting:

#### Product specific:

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.
- Strong forces which may affect the coplanarity of the components' electrical connection with the PCB (i.e. pins), can damage the component, resulting in avoid of the warranty.

#### Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the wire insulation, marking or plating. Washing agents may have a negative effect on the long-term functionality of the product.
- Using a brush during the cleaning process may break the wire due to its small diameter. Therefore, we do not recommend using a brush during the PCB cleaning process.

- If the product is potted in the customer application, the potting material might shrink or expand during and after hardening. Shrinkage could lead to an incomplete seal, allowing contaminants into the core. Expansion could damage the component. We recommend manual inspection after potting to avoid these effects.

#### Storage Conditions:
